Dear Mr. McGill and Mr. Klein:

On December 2, 2008, Defendants McGill Property Group, LLC, Garfield Land Development, LLC, GHLFP, John McGill (collectively defined as Defendants McGill) and City View Center, LLC (CVC) entered into a Consent Order and Final Judgment Entry filed in the Cuyahoga County Court of Common Pleas.

Paragraph 49, of the December 2, 2008, Consent Order states, in part, "Within 30 days of the date the Ohio EPA approves the plans for the Main Facility Gas System, Defendants McGill and CVC shall submit, to Ohio EPA for approval, detailed plans and schedules for the operation, maintenance and monitoring of the Main Facility Gas System."

On January 2, 2009, Ohio EPA received a document titled "Northeast Mound (NEM) and Main Facility Active Gas Extraction System Documents, City View Center." Each of the documents included an operations, maintenance and monitoring plan (OM&M). However, on February 19, 2009, Ohio EPA responded to the January 2, 2009, submittals with a notice of deficiency (NOD). This NOD included deficiencies from the OM&M portions of the submittals.

Also, on September 29, 2009, Ohio EPA approved the explosive gas extraction system through Final Findings and Orders.



As of the date of this letter, Ohio EPA has not received an adequate updated OM&M plan for the Main Facility or a response to the February 19, 2009, NOD. Defendants McGill and CVC therefore are in violation of Paragraph 49 of the December 2, 2008 Consent Order.

Nothing in this letter shall be construed to authorize any waiver from any requirements of applicable state solid waste laws or regulations. This letter shall not be interpreted to release MPG, GLD, GHLFP and CVC or others from responsibility under ORC Chapters 3704., 3714., 3734., or 6111; under the Federal Clean Water Act, the Resource Conservation and Recovery Act, or the Comprehensive Environmental Response, compensation, and Liability Act; or from other applicable requirements for remedying conditions resulting from any release of contaminants to the environment.
