Dear Mr. and Mrs. Dunlap:

In a letter dated December 12, 2008, I documented a violation of Ohio's construction and demolition debris (C&DD) rules that was observed on your property located at 5123 Bay Rd SE (subject property) in Lee Township, Carroll County, Ohio. Specifically, roofing shingles and roofing shingle wrappers were observed illegally disposed on the subject property. The letter required you to remove all C&DD illegally disposed on this property and properly dispose of it at a licensed C&DD or solid waste disposal facility. The letter also required receipts providing proof of disposal at a licensed C&DD or solid waste facility to be provided to Ohio EPA within 30 days of receiving the above letter. You acknowledged receipt of my letter on December 15, 2008.

I was in the vicinity of your property on January 6, 2009, and I was able to observe that the shingles and shingle wrappers had been removed. Upon receipt of documentation providing proof of proper disposal of these wastes at a licensed C&DD or solid waste facility, Ohio EPA shall consider this case closed. Thank you very much for your prompt and thorough response to my letter and for removing the aforementioned waste from your property.

Nothing in this letter shall be construed to authorize any waiver from the requirements of any applicable state or federal laws or regulations. This letter shall not be interpreted to release the owner(s) of this property, or others, from responsibility under Chapters 3704., 3714., 3734., or 6111. of the Ohio Revised Code or under the Federal Clean Water or Comprehensive Environmental Response, Compensation, and Liability Acts remedying conditions resulting from any release of contaminants to the environment.
