



Re: General Correspondence

Dear Mr. Bishop:

On March 22, 2004, I reinspected the Bishop's Truck Care facility in Monroe, Ohio. This reinspection was conducted as a follow-up to the November 3, 2003 Notice of Violation letter that cited violations observed during the initial investigation on October 23, 2003, pertaining to the improper storage of scrap tires at your facility.

On October 23, 2003, I observed multiple scrap tire piles located on the premises placing you in violation of Ohio Administrative code (OAC) Rule 3745-27-61(A)(2)(c). During the March 22, 2004 re-inspection, I observed one neatly stacked tire pile along the west side of the service garage in an area that occupies less than a twenty-five hundred square feet area. Your facility was in compliance with OAC Rule 3745-27-61(A)(2)(c) at the time of my re-inspection.

During the re-inspection I observed a flat bed trailer parked by the north side of the service garage loaded with tires. I was informed that the tires on the flat bed trailer and the single tire pile are in the process of being removed. Please provide the Ohio EPA with a copy of all shipping records for the disposal of the scrap tires from the registered scrap tire transporter. Please send the copies to Ohio EPA SWDO at the address listed on the letterhead.

The contents of this letter does not relieve Bishop Tire from its obligation to comply with other applicable requirements outlined in ORC Chapter 3734 and the rules promulgated thereunder, or its obligation to comply with other applicable State and Federal laws and regulations.
