Dear Ms. Winkler:

This letter is being sent to your attention as the property owner of record (in accordance to the Butler County Auditor's website on September 26, 2008).

I would like to thank Patty and Reagan Roarke for their cooperation in resolving the complaint of open dumping of municipal solid waste (MSW), including but not limited to, scrap tires, and construction and demolition debris (C&DD) at your property located at 5155 Augspurgen Rd, (Parcel No.L5220058000007), Hamilton, Butler County, Ohio.

On September 11, 2008, I met with Patty Roarke and conducted a follow-up inspection of the property located at 5155 Augspurgen Road (Parcel No.L5220058000007), Hamilton, Butler County, Ohio. The purpose of this inspection was to determine compliance with Ohio's Solid Waste Laws, Ohio Revised Code (ORC) 3734, 3714 and Ohio Administrative Code (OAC) 3734. This inspection was done as a follow-up to the Notice of Violation letter dated July 22, 2008 for the inspection conducted on July 8, 2008 and subsequent inspection conducted on August 27, 2008.

During my inspection on September 11, 2008, I observed the following:

The piles of miscellaneous municipal solid waste and C&DD have been removed from the property and the scrap tires have been removed from the northeast and northwest quadrant of the property near the storage garages and along the property boundary. In addition, the scrap tire pile on the southwest corner of the property has been removed

from the yard. All of the tires have been drained and are being properly stored in the barn to prevent harborage of mosquitoes. As seen in the photos of the initial inspection and re-inspection below (Figures 1-13, attachment A). The violations previously described during initial inspection conducted on February 8, 2008 and subsequent re-inspections on July 8, 2008, and August 27, 2008 have been abated.

Ms. Roarke indicated that the scrap tires would be properly stored in the large barn until the next scrap tire clean-up day in Butler County, or until a registered scrap tire transporter could be hired to properly remove the scrap tires for disposal.

**As a reminder, tires shall only be taken to the Butler County Cleanup Event or removed for proper disposal at a licensed scrap tire disposal facility. As discussed with Ms. Roarke during this inspection, receipts will need to be provided to Ohio EPA as evidence of proper disposal for the scrap tires for either option.**

Compliance with the requirements outlined in this letter shall not relieve you of your obligation to comply with other legal obligations, including, but not limited to, Chapters 3704, 3714, 3734, or 6111 of the Ohio Revised Code or under the Federal Clean Water Act, Clean Air Act, Comprehensive Environmental Response, Compensation, and Liability Act, or Resource Conservation and Recovery Act remedying conditions resulting from any release of contaminants to the environment.


Figure 9: Access gate to southeast side of property


Figure 13: Area next to barn abated
