Dear Mr. Carr:

The Ohio Environmental Protection Agency (Ohio EPA) Northeast District Office (NEDO) Division of Solid and Infectious Waste Management (DSIWM) has completed a review of the 2009 annual operational report for the Total Waste Logistics LAS LLC transfer facility located at 1025 Bundy Road, Girard, Trumbull County. The report was received on April 1, 2010.

Ohio EPA has identified the following violation:

OAC 3745-27-23(AA)(2)(e) requires that the annual report contain the "...annually adjusted final closure cost estimate required in rule 3745-27-15 of the Administrative Code and any relevant calculations..."

The 2009 annual report contained a final closure cost estimate, however, the estimate was a copy of the estimate submitted for the 2008 annual report. The estimate must be adjusted for inflation and the corresponding financial assurance instrument updated to reflect the increase.

Please submit a revised estimate to Ohio EPA by August 29, 2010. Additional comments and questions regarding the financial assurance instrument will be forwarded from Ohio EPA Central Office if the instrument has not been updated as required.

Nothing in this letter shall be construed to authorize any waiver from the requirements of any applicable state or federal laws or regulations. This letter shall not be interpreted to release the Entity from responsibility under Chapters 3704, 3714, 3734, or 6111 of the Ohio Revised Code or under the Federal Clean Water or Comprehensive Environmental Response, Compensation, and Liability Acts for remedying conditions resulting from any release of contaminants to the environment.
