CESSATION OF REGULATED OPERATIONS, 2nd NOTICE OF VIOLATION**

Dear Mr. Hays:

Please see the attached letter from Mr. Thomas Ploughe regarding the former Golden Aluminum Extrusion plant in Warren, Ohio. Mr. Ploughe has informed Ohio EPA that you are the contact for the facility.

Golden Aluminum has failed to respond to Ohio EPA's October 8, 2008 Notice of Violation (NOV) regarding the company's obligations under Ohio's Cessation of Regulated Operations (CRO) program for Golden Aluminum's former Warren Ohio, facility. The CRO program is regulated under Chapter 3750 of the Ohio Revised Code (ORC) and Chapter 3745-352 of the Ohio Administrative Code (OAC).

A copy of the NOV is attached. Golden Aluminum must respond to the NOV **within 15-days** of the date of this letter and submit copies of documentation regarding the disposition of all regulated materials that occurred prior to the transfer of the property to Gearmar Properties, Inc. Ohio EPA will work with Gearmar Properties on the disposition of the regulated materials that remained on the property after the date of transfer.

In addition, Golden Aluminum must submit documentation showing that the former hazardous waste tank at the Warren, Ohio Facility was closed in accordance with OAC rule 3745-52-34.


Ohio EPA will not certify that CRO obligations for the property have been fulfilled unless the requested documentation is received.
