Dear Commissioners:

On May 7, 2008, the Ohio Environmental Protection Agency (Ohio EPA), Division of Solid and Infectious Waste Management (DSIWM), Northwest District Office (NWDO), received a letter in response to November 21, 2007 and December 13, 2007 letters from Ohio EPA regarding the Wood County Landfill (Facility) located in Wood County. The submittal, dated May 6, 2008, was reviewed to determine compliance with Ohio Administrative Code (OAC) Rule 3745-27-10.

COMMENTS

Owner/Operator's Response to Previously Cited Violations

1. **The owner/operator has regained compliance with OAC Rule 3745-27-10(B)(3)(e).**

The August 28, 2007 letter from Ohio EPA cited the owner/operator in violation of OAC Rule 3745-27-10(B)(3)(e) regarding necessary maintenance to some of the ground water monitoring wells. The May 6, 2008 submittal indicates that the necessary maintenance has been performed for the appropriate monitoring wells. Therefore this issue has been addressed and the owner/operator has regained compliance with OAC Rule 3745-27-10(B)(3)(e).

Statements

2. **All issues of the November 21, 2007 letter from Ohio EPA have been adequately addressed.**

The November 21, 2007 letter from Ohio EPA contained three (3) comments regarding the August 2007 sampling event at the facility. Comment No. 1 of the November 21, 2007 letter was previously addressed by the owner/operator. Comments No. 2 and 3 of the November 21, 2007 letter were adequately addressed by the May 6, 2008 submittal.

3. All issues of the December 13, 2007 letter from Ohio EPA have been adequately addressed.

The December 13, 2007 letter from Ohio EPA contained four (4) comments regarding previous comment letters to the owner/operator. As detailed in Comment No. 1 above, Comment No. 1 of the December 13, 2007 letter was adequately addressed by the May 6, 2008 submittal. Comments No. 2, 3 and 4 of the December 13, 2007 letter were also adequately addressed by the May 6, 2008 submittal.
