Thank you for your April 14, 2009, response (received in this office on April 17, 2009) to Ohio EPA's February 18, 2009, Notice of Violation letter (NOV). I received the following information:

- ✓ Photographs indicating your lamps are properly labeled, dated and closed.
- ✓ A universal waste management plan for the management of your lamps.
- ✓ Photographs documenting containers and tanks storing used oil are properly labeled "Used Oil".
- ✓ Waste evaluation documentation for your used oil and absorbent waste stream indicating this material is non-hazardous.

My review of this documentation reveals that Sims Bros., Inc. has adequately demonstrated abatement of the violations discovered during the January 28, 2009, inspection as listed below:


