Dear Mr. Dipman:

On July 26, 2007, Ohio EPA conducted a complaint investigation of Motor Cargo Inc. (Motor) located at 23046 W SR 51 in Clay Township. The purpose of this visit was to investigate a complaint received by the Division of Hazardous Waste Management (DHWM) with concerns about proper disposal of used oil. The investigation included a tour of the facility and a review of your disposal practices.

Motor is a trucking business that changes oil at the above mentioned address. The used oil is picked up by Disc Environmental. Motor was found to be handling their used oil properly. However, during the complaint investigation, I found the following violation of Ohio's hazardous waste laws. In order to correct this violation you must do the following and send me the required information **within 30 days** of your receipt of this letter:

- 1. Used oil storage requirements - proper labels.
OAC 3745-279-22 (C) (1)**

Containers used to store used oil shall be labeled or marked clearly with the words "Used Oil."

Motor failed to mark all their containers that store used oil with the words "Used Oil."

In order to abate this violation, Motor must mark or label the containers that store used oil with the words "Used Oil" immediately. In addition, Motor must submit photo documentation showing that the used oil drums have been properly labeled.

Ohio EPA will issue an EPA ID number to track our inspection activity at Motor. Motor can not use this number for manifesting hazardous waste shipments. If Motor wants to

use an EPA ID number for manifesting and other hazardous waste, used oil or universal waste activities, Motor must complete and submit a Notification of Regulated Waste Activity form (EPA Form 9029 (Rev. 11/2002)) to Ohio EPA. This form is available on our Web page at <http://www.epa.state.oh.us/dhwm/notiform.html> or Motor can call me at (419) 373-3058 or the Division of Hazardous Waste Management, Central Office, RIS at (614) 644-2977 and we will mail you a copy.


