Dear Mr. Smith:

Thank you for accompanying Gary Deutschman and me during the Ohio Environmental Protection Agency's (Ohio EPA's) January 16, 2008, inspection of Stykemain Chevrolet-Pontiac, Inc.'s (SCPI's) facility located in Paulding, Ohio. We inspected SCPI to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). During the inspection, we also helped you identify ways to prevent pollution by reducing waste.

This letter will explain the violations we found, what you need to do to correct the violations, other general concerns we have, what you need to do to respond to our general concerns, and the pollution prevention opportunities we identified.

SCPI is a non-generator of hazardous waste that conducts automotive maintenance. SCPI also generates used oil, batteries, and spent lamps.

We found the following violations of Ohio's hazardous waste laws. In order to correct these violations you must do the following and send me the required information ***within 30 days of your receipt of this letter:***

Violations:

1. **OAC Rule 3745-52-11, Hazardous Waste Determination:** "Any person who generates a waste, as defined in rule 3745-51-02 of the Administrative Code, must determine if that waste is a hazardous waste..."

SCPI failed to have waste evaluation documentation or an established recycling plan in place for the fluorescent bulbs generated at the facility.

SCPI must immediately cease disposing of the fluorescent bulbs as non-hazardous waste until a proper waste evaluation has been completed. Fluorescent bulbs typically contain mercury and other heavy metals which could make them a hazardous waste. Hazardous waste bulbs are considered "spent materials" and remain hazardous waste even when recycled. Hazardous waste lamp generators have the option of handling their lamps as hazardous waste or as universal waste. Managing hazardous waste lamps under the universal waste rules eases certain regulations imposed on generators of spent lamps.

SCPI must submit to Ohio EPA documentation to demonstrate how you plan to properly manage your fluorescent bulbs. If SCPI decides to sample the bulbs, then SCPI must evaluate all types and brands of lamps at the facility using a toxicity characteristic leaching procedure (TCLP) test for Resource Conservation and Recovery Act (RCRA) metals. The other alternative is that SCPI can begin to manage spent bulbs as universal waste as discussed during the inspection. Ohio EPA recommends that spent bulbs be managed as a universal waste and recycled.

If SCPI decides to manage their bulbs as a waste, then SCPI will need to sample each type and brand of bulb at the facility and submit the analytical results to Ohio EPA, along with a description of how they will be managed. Otherwise, SCPI should submit a bulb management plan that outlines how the spent bulbs will be managed as universal waste and where they will be shipped. SCPI should also submit photographic documentation that a closed container will be used and that this container has the proper label and accumulation start date located on it. This information should be submitted to Ohio EPA ***within 30 days of receipt of this letter.***

I have included the following fact sheets on spent bulbs for your information: Universal Waste Rules for Handlers of Lamps, dated June 2005; Fluorescent Lamps: What You Should Know, dated January 2007; and Computer, Fluorescent Lamp and Ballast Recyclers, dated December 2007.

2. **OAC Rule 3745-279-22 (C)(1), Used Oil Storage Requirements for Generators:** "Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words 'Used Oil.'"

SCPI failed to mark their used oil tote located behind the building with the words "Used Oil."

The used oil drum was marked with the words "Used Oil" while Ohio EPA was on site.

Therefore, this violation was abated on January 16, 2008.

General Concern:

- A. **Used Oil Tote Area:** Ohio EPA would like to remind SCPI that OAC Rule 3745-279-22 (D), *Used Oil Requirements for Generators*, states "Response to releases. Upon detection of a release of used oil to the environment that is not subject to the requirements of Chapter 1301:7-9 of the Administrative Code and which has occurred after October 20, 1998, a generator must perform the following cleanup steps: (1) Stop the release; (2) Contain the released used oil; (3) Clean up and manage properly the released used oil and other materials; and (4) If necessary, repair or replace any leaking used oil storage containers or tanks prior to returning them to service."

At the time of the inspection, the used oil tote area was surrounded with decaying leaves. It does not appear that used oil has been spilled in this area. However, if a spill does occur in this location, the decaying leaves will add to the amount of waste that is generated during the clean up. Ohio EPA recommends that these leaves be removed from this area or that the used oil tote location be moved inside.

For more information, I have also included the fact sheet titled Universal Waste, dated December 2004.

As we discussed during the inspection, you may be able to reduce the waste your company generates. If you find ways to recycle, reduce, or altogether eliminate the amount of waste that your company generates you may be able to reduce treatment and disposal costs.
