Dear Mr. Bixler:

On August 31, 2010, Ohio EPA, Division of Hazardous Waste Management conducted a hazardous waste compliance evaluation inspection (CEI) of HDT Engineered Technologies (HDT) located at 4080 Park Avenue West, Mansfield, Ohio. This inspection was conducted to determine HDT's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC), and Ohio's hazardous waste regulations as adopted under Chapter 3745. of the Ohio Administrative Code (OAC). HDT was represented by Jim Zeno and you. Ohio EPA was represented by the writer. The inspection included a tour of the facility and review of facility paperwork.

HDT assembles carbon filters used in military applications as chemical blockers. These filters are utilized in buildings and vehicles. HDT utilizes acetone to clean parts and tools. HDT is a conditionally exempt small quantity generator of hazardous waste from the spent acetone (D001, F003). HDT is a used oil generator from the changing of air compressor oil. HDT manages lamps as universal waste.

During the inspection, I gave you the following information: the fact sheets Universal Waste Rules for Handlers of Lamps; The Regulation of Used Oil: An Overview for Ohio Businesses Who Generate Used Oil and a generator category sheet.

I found the following violations of Ohio's hazardous waste laws:

**1. Used oil storage requirements - proper labels.
OAC Rule 3745-279-22 (C) (1)**

Containers used to store used oil shall be labeled or marked clearly with the words "Used Oil."

HDT failed to mark one drum containing used oil with the words "Used Oil."

This drum was labeled "Used Oil" during the CEI, thus this violation is abated.

**2. Waste management - standards for small quantity handlers of universal waste (lamps).
OAC Rule 3745-273-13 (D) (1)**

A small quantity handler of universal waste must manage lamps in a way that prevents releases of any universal waste or component of a universal waste to the environment by containing lamps in containers or packages and such containers must remain closed.

HDT was storing three boxes of lamps. These boxes were not closed, thus, these lamps were not in a container that was closed.

All boxes that contained spent lamps were closed during the CEI, thus this violation is abated.

We discussed if HDT could utilize something other than acetone as a parts cleaner. In addition, we also discussed if there was a use or way to recycle the waste carbon that is generated at your facility. I stated that it may be possible for our Office of Compliance Assistance and Pollution Prevention (OCAPP) to assist you in alternatives for these waste streams. You can either contact Ron Nabors at 419-373-3147 or ron.nabors@epa.ohio.gov (OCAPP) or me if you are interested in such an assessment. If you find additional ways to recycle, reduce, or altogether eliminate the amount of waste that your company generates you may be able to reduce treatment and disposal costs. 


