Dear Mr. Lamprecht:

On January 12, 2011, Wendy Miller and I conducted a compliance evaluation inspection at Bavarian Autosport, Inc. (hereafter referred to as BAI) located at 672 West Boundary in Perrysburg, Ohio. We inspected BAI to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). During our visit we spoke with your employee, Doug, and observed your operations. Pollution prevention options were also discussed during this inspection. This letter will explain the violation found and what you need to do to correct this violation.

BAI is a full service automobile shop that specializes in service and repair work for BMW, Volvo and Mini Cooper. Used oil is generated and stored in three 250-gallon storage tanks located in the shop area. The used oil is burned in an on-site furnace to heat the building. Used oil filters are hot drained and then disposed of as solid waste. BAI no longer does painting. BAI services the one parts washer and adds Zep Dyna 143[®] solvent as needed. Safety Kleen picks up and recycles the antifreeze and brake fluid generated at your shop. Spent fluorescent lamps are managed as a solid waste. At the time of our inspection, BAI was operating as a non-generator of hazardous waste.

We found the following violation of Ohio's hazardous waste laws. In order to correct this violation you must do the following and send me the required information within 30 days of your receipt of this letter:

1. Waste Evaluation, OAC Rule 3745-52-11:


Any person who generates a waste must determine if that waste is a hazardous waste by using generator knowledge or by testing the waste.

BAI failed to have waste evaluation documentation or an established recycling plan in place for the fluorescent bulbs generated at the facility. At the time of our inspection, one spent fluorescent bulb was located in the old paint room.
