Dear Ms. Hatfield:

On July 1, 2009, I investigated a complaint at Interstate Bakeries Corporation (IBC) located at 3818 Woodville Road, Northwood, Ohio. The complaint was received by the Division of Hazardous Waste Management on June 18, 2009. The complainant stated that the facility contained an in-ground pit. The complainant stated there are five pits in the "area" (Interstate facilities) and that at least two of the five pits are leaking hydraulic oil and these pits were identified by Interstate five years ago as requiring remediation. This letter will explain the validity of the complaint, the violation I found, what you need to do to correct this violation, one area of concern and what you need to do to satisfy this area of concern.

Upon arriving at IBC, I discussed the complaint with Rich Watterson and Jim James and I proceeded to conduct a full compliance evaluation inspection (CEI) to determine IBC's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC), and Ohio's hazardous waste regulations as adopted under Chapter 3745. of the Ohio Administrative Code (OAC). This inspection included a tour of the facility. I met with you on July 2, 2009, at your Wales Road facility to review the facility paperwork (for Woodville Road).

IBC is a bakery outlet for retail sale of goods. The facility also has on-site a service garage for the delivery trucks. IBC is a conditionally exempt small quantity generator of hazardous waste. Hazardous waste generated is spent solvent from the parts washer (D001). Other wastes generated at the facility include antifreeze, used oil, used oil filters, and fluorescent bulbs.

I found the following violation of Ohio's universal waste laws. In order to correct this violation you must do the following and send me the required information **within 30 days** of your receipt of this letter:

1. **Employee training for small quantity handlers of universal waste (SQUWH).
OAC Rule 3745-273-16**

A SQUWH shall inform all employees who handle or have responsibility for managing universal waste. The information shall describe proper handling and emergency procedures appropriate to the type(s) of universal waste handled at the facility.

Upon speaking with you, you stated that the lamps at IBC are managed as universal waste. You then provided me the invoice for the recycling of the lamps from IBC. However, when I spoke with Mr. James at IBC he stated he thought that Granger picked up their bulbs. You stated that Granger is your supplier of bulbs. It appears that IBC is unsure where their bulbs are going for recycling or how to properly manage them.

- ***To abate this violation, please submit to me a universal waste training plan indicating that the employees understand proper management, handling and emergency procedures for the management of lamps.***

Area of Concern:

Pit with Hydraulic lift.

Ohio EPA needs more information pertaining to the pit which contains the out-of-service hydraulic lift to assess compliance with the hazardous waste regulations. Please provide a general narrative description of the unit and its uses while including answers to the following questions:

- A. Did IBC ever actively utilize these pits? If so, were they taken out of service? If so, when?
- B. Was the hydraulic fluid from the lifts ever removed? If so, when?
- C. Were/are there releases from **the lifts** into the pit that IBC is aware of?
- D. If there were releases what is your timeline for cleaning up these releases?
- E. Does the pit generally hold at any given time various amounts of used oil? If so, what is the source of the used oil?
- F. Does the pit contain used oil now?
- G. Are there any additional tanks associated with the hydraulic lifts which may contain hydraulic fluid or any other material?

Additionally, Ohio EPA needs more information pertaining to the waste that was generated from this pit to assess compliance with the hazardous waste regulations. Please provide a general narrative description of how the waste was generated while including answers to the following questions:

- H. On February 5, 2009, DISC Environmental picked up 15 drums of waste water/oil/sludge from this pit. How did oil get into the pit? What is the exact source of this oil?
- I. Did the pit contain used oil prior to the flood? Did water then come under the garage door then flow into the pit with oil thus creating an oil/water mixture? Or was the pit empty and a used oil/water mixture went into the pit? If so, what is the source of the used oil/water mixture that went into the pit?
- J. Did IBC request or did DISC do analytical on this waste material to determine if it was hazardous or not? If so, please provide this information.
- K. How did IBC make the determination that this material was used oil?
- L. What is IBC doing now to prevent oil from getting into this pit? And/or what is IBC doing now to prevent creating this additional waste stream?

- To satisfy this area of concern please answer all of these questions and provide any additional information which may help or address this issue. *Please note that based on your response to these questions additional violations may be cited.*



Furthermore, you may possibly reduce your regulatory requirements.
