Dear Mr. Harpst:

Thank you for your April 29, 2010 response to Ohio EPA's April 15, 2010 Notice of Violation letter. The email you submitted indicated that Gene Stevens Honda will begin managing spent fluorescent lamps as universal waste.

In addition, Wendy Miller and I visited your facility on April 29, 2010, to attempt to sample the spent oily sludge generated from your detergent parts washer. However, we found that Gene Stevens Honda has not generated a sufficient quantity of waste to properly obtain a representative sample for analysis. You indicated that Gene Stevens Honda only uses the detergent parts washer periodically

My review of your e-mail and based on our findings from the April 29, 2010 visit, Gene Stevens Honda has abated all violations discovered during the April 1, 201 inspection as listed below.



General Comment:

Gene Stevens Honda should not dispose of the oily sludge discharged from the detergent parts washer located in the service department until a proper evaluation of the oily sludge has been conducted. Since this unit is only used periodically, Gene Stevens Honda should notify me when the drip pan located on the side of the parts washer becomes nearly full. At that time Gene Stevens Honda should analyze a representative sample of the oily sludge for pH, total volatile organic compounds (VOC's) and Resource Conservation and Recovery Act (RCRA) metals using methods as outlined in U.S. EPA's SW-846. This information should be submitted to my attention at the Ohio EPA within 30 days of receipt of this letter.
