Dear Mr. Snoke:

Thank you for accompanying me during Ohio EPA's July 29, 2011, hazardous waste compliance evaluation inspection (CEI) of Forest Truck & Auto Parts, LLC (Forest Truck) located at 500 South Madriver Street, Forest, Ohio. I inspected Forest Truck to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC), and Ohio's hazardous waste regulations as adopted under Chapter 3745. of the Ohio Administrative Code (OAC). The inspection included a tour of facility operations and a review of facility paperwork. This letter will explain the violations I found, what you need to do to correct these violations and one general comment.

D and R Parts and Equipment had notified Ohio EPA on June 18, 1990, that they were a small quantity generator of hazardous waste (D001, D002) at this address with the U.S. EPA ID # OHD986981728. You stated that this facility was sold to Forest Truck and that Forest Truck has been at this address for the last four years.

Forest Truck is an automobile service and parts shop. Forest Truck only provides repairs and does not conduct auto body work. Forest Truck is a used oil generator. Forest Truck has a parts washer but to date has not generated any waste from the parts washer. Wastes generated at your facility include used oil filters, used oil, antifreeze, lead-acid batteries and lamps.

During the inspection, I gave you the following information: the Ohio EPA publication Environmental Compliance Guide for Auto Repair Shops – March 2007; the Ohio EPA fact sheets Identifying your Hazardous Waste; Universal Waste Rules for Handlers of Lamps; Fluorescent Lamps: What you Should Know; The Regulation of Used Oil: An Overview for Ohio Businesses Who Generate Used Oil; a sample universal waste management plan for lamps and a list of lamp recyclers in Ohio.

I found the following violations of Ohio's hazardous waste laws. In order to correct these violations you must do the following and send me the required information **within 30 days** of your receipt of this letter:

**1. Waste Evaluation.
OAC Rule 3745-52-11**

Any person who generates a waste must determine if that waste is a hazardous waste in accordance with the criteria for hazardous waste as set forth in Chapter 3745-51 of the Administrative Code.

Forest Truck failed to have waste evaluation documentation or an established recycling plan in place for the fluorescent bulbs generated at the facility.

Forest Truck is currently disposing of their fluorescent bulbs in the trash. Forest Truck must cease disposing of their fluorescent bulbs as non-hazardous waste in the local landfill until a proper waste evaluation has been completed or begin managing as a universal waste.

A waste evaluation can be conducted by taking a representative sample of this waste to properly evaluate this waste stream through a laboratory analysis which lists constituents present and at what concentration. Forest Truck must ensure that the laboratory chosen to perform this sampling utilizes the proper method(s) to evaluate these bulbs. Forest Truck must sample the fluorescent bulbs to determine the Toxicity Characteristic Leaching Procedure (TCLP) concentrations of barium (D005), cadmium (D006), lead (D008), and mercury (D009) as listed in OAC Rule 3745-51-24 following the methods as outlined in U.S. EPA's SW-846.

If the bulbs are determined to be hazardous through a proper waste evaluation, Forest Truck will have to manage their bulbs either as 1) a universal waste (OAC Chapter 3745-273), or 2) as a hazardous waste under Ohio's generator standards (OAC Chapter 3745-52). FTC may recycle their bulbs if they are hazardous or non-hazardous. Ohio EPA would encourage this option as a pollution prevention alternative.

In lieu of conducting a waste evaluation, Forest Truck may choose to manage their bulbs as a universal waste as outlined in OAC Chapter 3745-273. Please consult the fact sheet Universal Waste Rules for Handlers of Lamps given to you during the inspection for more information. If you choose this option, please provide me an outline of your universal waste management plan (see the sample universal waste management plan given to you during the CEI).

- ***To abate this violation, please submit to me your waste evaluation of your lamps (either proper characterization from the manufacturer or your sampling analytical) or an outline of your universal waste management plan (indicating how you will manage, label, send off-site within one year, where lamps will be recycled, etc.)***

**2. Used oil storage requirements - proper labels.
OAC Rule 3745-279-22 (C) (1)**

Containers used to store used oil shall be labeled or marked clearly with the words "Used Oil."

Forest Truck failed to mark their used oil tank containing used oil with the words "Used Oil."

- ***To abate this violation, please submit photograph documentation indicating that your tank used to store used oil has been properly labeled "Used Oil".***

General Comment:

Waste generated from parts washer.

You stated during the CEI that to date you have not changed the solvent in your parts washer (10 gallons). It currently contains NAPA Mac's parts cleaner liquid. I looked at this Material Safety Data Sheet (MSDS). The solvent has a flashpoint of 160 Fahrenheit and based on the MSDS ingredients listed does not contain any hazardous characteristics. We discussed how in the future if you all do change this fluid that you will have to properly evaluate this material to determine all possible characteristics for this waste based on the uses (cleaning of parts, maintenance activities). We also discussed how as a non-generator of waste (currently) or possibly a conditionally exempt generator of hazardous waste in the future (if you determine that your parts washing waste is hazardous or if you generate other hazardous waste) that you may be able to mix this waste in with your used oil and burn it for energy recovery so long as a proper waste evaluation has been conducted first on the parts washing fluid waste stream.

Pollution Prevention:

Forest Truck is recycling their properly drained used oil filters as scrap metal with Danner's Towing and Recycling and their lead acid batteries with Dekra.

Forest Truck is burning their used oil generated on-site for energy recovery.

Forest Truck either re-uses their drained antifreeze back into the vehicle from which it was generated or uses it for other equipment.

If you find additional ways to recycle, reduce, or altogether eliminate the amount of waste that your company generates you may be able to reduce treatment and disposal costs. Furthermore, you may possibly reduce your regulatory requirements. 
