Dear Mr. Blank:

On September 6, 2011, Ohio EPA received your response to the agency's Partial Return to Compliance (PRTC) letter dated July 1, 2011. You submitted a photograph of your universal waste lamps in two boxes.

My review of this documentation reveals that RRC has adequately demonstrated abatement of the following violations, discovered during my June 21, 2011, inspection: OAC Rule 3745-273-13(D)(1) and 3745-273-15(C). RRC previously abated three violations of OAC Rule 3745-52-11 on July 8, 2011.

RRC remains in violation of the following rules as cited in Ohio EPA's March 23 and July 1, 2011, NOVs. In order to correct the remaining violations, you must do the following and send me the required information, **within 30 days** of your receipt of this letter:

- 1. Unpermitted Hazardous Waste Treatment, Storage & Disposal
ORC Section 3734.02(E)&(F) (two violations)**

and

**Causing the Transportation of Hazardous Waste to an Unauthorized Facility
ORC Section 3734.02(F) (one violation)**

- A. RRC must submit to Ohio EPA a plan to close all the hazardous waste management units.**

- B. RRC must make arrangements to have the hazardous waste it has accumulated in containers shipped to a permitted treatment, storage or disposal facility immediately and submit to Ohio EPA a copy of the hazardous waste manifest and land disposal restriction form used to transport the waste off-site.**
