RE: Liberty Township Landfill – August 4, 2009, Inspection

Dear Ms. Manson:

On August 4, 2009, I conducted an inspection of your township's closed landfill facility located off Lancaster Road. The purpose of my inspection was to determine your compliance with closure requirements as stipulated in Ohio Administrative Code (OAC) Rule 3745-27. The weather and ground conditions at the time of the inspection were cloudy and damp with a temperature of about 80 degrees.

Our files indicate that the landfill ceased acceptance of waste on October 22, 1988. Landfills which ceased acceptance of solid waste prior to April 1, 1990, are subject to compliance with specific closure requirements of the Ohio Administrative Code (OAC).

During my latest inspection, I observed the landfill to be well vegetated. The site had been recently mowed to control woody vegetation. An area that had been affected in the spring by a neighbor attempting to construct a small motocross course on the cap has been repaired and revegetated.

The following violation of OAC Rules 3745-27-12 was found to exist:

OAC Rule 3745-27-12 - The operator is required to submit an explosive gas monitoring plan by February 1, 1989. You were initially informed of this requirement by letter dated January 12, 1989. To date, this Agency has not received the required plan.

On November 1, 1990, Liberty Township (Liberty) submitted a request pursuant to Ohio Revised Code (ORC) Section 3734.02(G) to be exempted from the requirements of this rule. From 1997 through 2000, Ohio EPA assisted Liberty in performing several explosive gas monitoring events. The results were inconclusive, requiring further monitoring to support Liberty's exemption request.
