Dear Mr. and Mrs. Lott:

On April 7, 2006, the Ohio Environmental Protection Agency received a complaint concerning property owned or controlled by you at 200 Greenhill Road in Washington County. This complaint alleged the open dumping of various solid wastes on this property. On April 12, 2006, I investigated this complaint and found it to be valid. I observed the accumulation of solid waste on this property.

On September 17, 2007, I inspected this property again and found that no clean up activities had begun.

- Pursuant to (ORC) Section 3734.03 and (OAC) Rule 3745-27-05(C), "No person shall conduct, permit, or allow open dumping. In the event that open dumping is occurring or has occurred at a property, the person responsible for the open dumping, the owner of the property, or the person who allows or allowed open dumping to occur, shall promptly remove and dispose or otherwise manage the solid waste in accordance with Chapter 3734, of the Revised Code, and shall submit verification that the solid waste has been properly managed."

The solid waste that is open dumped on your property is in violation of ORC Section 3734.03 and OAC Rule 3745-27-05(C).


Please respond to this correspondence within 14 days of receipt. Your response should include details of your actions taken to properly dispose or recycle the solid waste open dumped on your property.

Nothing in this letter shall be construed to authorize any waiver from the requirements of any applicable state or federal laws or regulations. This letter shall not be interpreted to release the owner or operator from responsibility under Chapters 3704, 3714, 3734, or 6111 of the Ohio Revised Code on under the Federal Clean Water or Comprehensive Environmental Response, Compensation, and Liability Acts for remedying conditions resulting from any release of contaminants to the environment.
