Dear Mr. Johnson:

On December 6, 2011, Rich Stewart and I inspected Quik Stop Lube & Tire in Piketon, Ohio to determine Quik Stop Lube & Tire's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). During the inspection I also helped you identify ways to prevent pollution by reducing waste. This letter will explain the violation I found and what you need to do to correct the violation.

I found the following violation of Ohio's hazardous waste law. In order to correct this violation, you must do the following and send me the required information ***within 30 days*** of your receipt of this letter:

- (1) **Used oil storage requirements for generators, OAC rule 375-279-22(C)(1):** Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

During the inspection, two used oil containers were not labeled as required above. To demonstrate compliance with this rule, these containers must be labeled appropriately and photographic documentation must be sent to this office for review.
