Dear Mr. Wilson:

On December 20, 2011, I inspected Frederick's Auto located at 8003 Broadway Avenue, Cleveland, Ohio. The purpose of this was to determine if Frederick's Auto was in compliance with Ohio's hazardous waste and used oil laws and rules as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC).

The following violations were found: (These follow the order of the enclosed checklist.)

1. OAC Rule 3745-279-22(C) - Used oil labels.

This rule requires containers and aboveground tanks for used oil to be labeled or marked clearly with the words "Used Oil".

Frederick's Auto violated this rule by having a drum of used oil that was not labeled as used oil. This was corrected during the inspection.

2. OAC Rule 3745-279-22(D) - Response to releases of used oil.

This rule requires that upon detection of a release of used oil to the environment, the generator must clean up and manage properly the released used oil and other materials.

Frederick's Auto violated this rule by not removing the oil-soaked oil dry at the base of its drum of used oil. This oil dry was correctly used to soak up a used oil spill but now must be removed and disposed of properly. If it is only contaminated with used oil, then it should be disposed of with your regular trash (as a solid waste). **Please send me a letter confirming that this has been done.**

In addition, the drum of used oil was open. We closed it during the inspection. Since this drum is kept outside, it should be kept closed to avoid rain water from overflowing it and to avoid rain water contaminating the used oil which could lead to a higher disposal cost for you.

Frederick's Auto needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, Frederick's Auto is requested to provide documentation to me including the steps taken to abate the violations cited above. Such documentation may include written correspondence, updated policies, and photographs, as appropriate.

Please be advised that violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734. (or 3714 for C&DD) of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. It is imperative that you return to compliance. If circumstances delay the abatement of violations, Frederick's Auto is requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.
