**RE: KINNEY'S AUTOMOTIVE SERVICE, COMPLAINT #7486
NOTICE OF VIOLATION/RETURN TO COMPLIANCE**

Dear Mr. Beal:

On December 9, 2011, the Ohio EPA, represented by Edward D'Amato and Robert Almquist, conducted a complaint inspection at Kinney Automotive. The complaint alleged improper management of automotive fluids. The complaint was unfounded; however, the following violation was noted:

**1. Labeling of Used Oil Containers
OAC 3745-279- 22(C)**

Containers and above ground tanks used to store used oil at generator facilities shall be labeled or marked clearly with the words "Used Oil"

Two used oil tanks and one portable used oil container were not labeled per this rule. This violation was corrected on December 12, 2011 when pictures showing these items had been labeled were received via e-mail from your facility.

No response to this letter is required. Enclosed is a copy of the checklist used for the inspection.

Failure to list specific deficiencies in this communication does not relieve Kinney Automotive from the responsibility of complying with all applicable Ohio EPA laws and regulations. Please be advised that present or past instances of non-compliance can continue as subjects of pending or future enforcement actions.
