Subject: Failure to Monitor Drinking Water

DFC Mobile Home Park is in violation of Ohio Administrative Code Rule (OAC) 3745-81-23 for failing to monitor your drinking water during the January 1 to March 31, 2009 monitoring period and/or report results for the following contaminants: NITRATE.

In order to return to compliance, DFC Mobile Home Park must take the following actions:

1. Immediately collect a sample of your drinking water from the entry point (first tap after treatment).
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.

DRINKING WATER NOTICE

Monitoring requirements not met for DFC Mobile Home Park

We are required to monitor your drinking water for specific contaminants on a regular basis.
