Re: ILLEGAL OPEN BURNING AT YOUR PLACE OF BUSINESS IN SUGAR CREEK TOWNSHIP

Dear Mr. Weaver:

The Canton City Health Department, Air Pollution Control Division (APCD) represents the Ohio EPA in air quality matters within Stark County. APCD employees are charged with the responsibility to investigate and enforce Ohio EPA (OEPA) air pollution regulations.

I was at your place of business on September 22, 2011 and documented a large open burning pile used for the disposal of waste wood. Please be advised that this is in violation of Ohio EPA regulations, specifically Ohio Administrative Code Rule 3734-19-04, which makes no provisions for open burning of waste produced by commercial enterprises.

Open burning for recreational purposes, such as campfires and cookouts, is permitted subject to the limitations in OAC 3745-19-04(B)(2). Since your place of business is in an unrestricted area, open burning of residential and agricultural waste is also permitted, subject to the limitations in OAC 3745-19-04 (B)(3).

There is no enforcement planned at this time, but be aware that future violations could result in monetary fines.




