**NOTICE OF VIOLATION - ACTION REQUIRED**

**Subject: Failure to Monitor Drinking Water**

Springfield Racquet Club is in violation of Ohio Administrative Code Rule 3745-81-23 for failing to monitor your drinking water during the January 1, 2009 to December 31, 2009 monitoring period and/or report results for the following contaminants: NITRATE (AS N)

In order to return to compliance, Springfield Racquet Club must take the following actions:

1. Immediately collect a sample of your drinking water from the entry point (first tap after treatment).
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.

# DRINKING WATER NOTICE

## Monitoring requirements not met for Springfield Racquet Club

We are required to monitor your drinking water for specific contaminants on a regular basis.
