Subject: Violation of Maximum Contaminant Level for TOTAL HALOACETIC ACIDS (HAA5)

Rolling Ridge Water Co. is in violation for exceeding the maximum contaminant level (MCL) standard of 0.060 MG/L as established in the Ohio Administrative Code (OAC) section 3745-81-12 for HAA5. Compliance with the MCL is based on a running annual average. The annual average for HAA5 during the First Quarter of 2011 time period is 0.121 MG/L.

To address the MCL violation, Rolling Ridge Water Co. is required to take the following actions:

1. Notify your customers within 30 days using the enclosed instructions and public notice.
2. Complete and send a verification form with a copy of the public notice to the mailing address below within ten days after issuance.
3. Perform quarterly monitoring for HAA5 during each calendar quarter (January 1 – March 31; April 1 – June 30; July 1 – September 30; October 1 to December 31).
4. Consult with your Ohio EPA district representative to discuss your options for coming into compliance and establishing a compliance schedule or comply with any previously issued enforcement action.

Your prompt attention to this matter is greatly appreciated. Continued noncompliance may lead to additional enforcement actions. If you have any questions or wish to change the public notice, please call me at (614) 644-2752.

DRINKING WATER NOTICE

Rolling Ridge Water Co. Has Levels of TOTAL HALOACETIC ACIDS (HAA5) above Drinking Water Standards

Our water system recently violated the maximum contaminant level (MCL) for HAA5. The average level of HAA5 over the last four quarters was 0.121 MG/L. The standard for HAA5 is 0.060 MG/L.

What should I do?

- **You do not need to use an alternative (e.g., bottled) water supply.** However, if you have specific health concerns, consult your doctor.

What does this mean?

The levels detected do not pose an immediate risk to your health. However, some people who drink water containing haloacetic acids in excess of the MCL over many years may have an increased risk of getting cancer.

What is being done?

We are investigating and taking the necessary steps to correct the problem as soon as possible.
