SUBJECT: CCR VIOLATIONS (Type 72)

Ohio EPA received the 2008 Consumer Confidence Report (CCR) for the Village of Sugar Grove public water system. The CCR was reviewed for the required content. Based on our review, the Village of Sugar Grove public water system is in violation of the Ohio Administrative Code (OAC) Rules 3745-96-01 through 04 for failure to comply with the CCR requirements. The following violations were noted:

1. The Table of Detected Contaminants did not include all the contaminants specified in OAC 3745-96-02(D) (i.e. Lead).
2. The CCR did not include Violation Information required in OAC 3745-96-02(F) (TTHM/HAA5 Monitoring & Reporting Violation for the 3rd Qtr of 2008).
3. Good Faith Efforts to reach all non-bill paying consumers, as required by OAC 3745-96-04(B), were not made (as per 7/08/09 CCR Certification Form).

Be sure to correct the violation(s) as appropriate in your next CCR. The next report for calendar year 2009 must be sent to your customers by no later than July 1, 2010. A copy of the CCR along with a Certification Form must be submitted to the Central District Office at the above address.
