**Subject: Notice of Violation – Failure to Submit Operational Reports**

Dear Mrs. McInturff:

Ohio EPA has not received any Monthly Operating Reports (MORs) for the Green Meadows Mobile Home Park (GMMHP) since May 2009. We have sent you numerous violation letters, but as of this date we have not received a response from you.

Within 15 days of the date of this letter, please submit copies of the Plant-Distribution MOR's (Form 5002) that cover the period between May 2009 and February 2010 and copies of Quarterly Monitoring Reports (Form 5141) for Total Chlorine that cover the year 2009.

As the operator of record you are required to report all instances of noncompliance to the Ohio EPA. You are also required to record the steps you took to correct these in the water system's logbook (OAC 3745-7-09 (B)(C)).

I am recommending you submit the MORs electronically. Ohio EPA has a new web based program for submitting the MORs. The web based program is called "Electronic Drinking Water Reports" or eDWR for short. You can verify and submit your reports from any computer connected to the internet.


