Dear Ms. Elliott:

In accordance with Ohio Administrative Code (OAC) 3745-83-01(I)(2), public water systems are required to submit monthly operational reports to Ohio EPA Division of Drinking and Ground Waters by the tenth of the month following the reporting month and that the reports be signed by the Operator of Record.

Our records indicate that the North Point Cove Condominiums monthly operating reports between January and May of 2009 were not signed by the operator of record. This represents a violation of the above rule.


