Dear Mr. Peterson:

On March 25, 2010, Ohio EPA conducted a complaint investigation and a compliance evaluation inspection of Packaging & Pads-R-Us (PPRU) located in Milan, Ohio. The purpose of this visit was to determine PPRU's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). The inspection included a tour of the facility and a review of your disposal practices.

PPRU manufactures corrugated cardboard which is made into packaging products. At the time of inspection, Ohio EPA considered PPRU a non-generator of hazardous waste. PPRU uses Dyna 143 (non-hazardous) in their parts washers. Chemtron picks up their wash water (non-hazardous). PPRU also generates used oil. Currently, only two 55 gallon drums have been accumulated to date and no used oil has been transported off-site since the business has started at this location 2 years ago.

During the inspection, PPRU stated that no fluorescent bulbs have been generated to date. Please be aware that incandescent, fluorescent, metal halide, neon, high-intensity discharge, high-pressure sodium and mercury-vapor lamps could be hazardous waste when discarded. Fluorescent lamps may contain up to 40 milligrams (mg) of mercury, depending on the brand and manufacturer. Lamps may also contain lead and cadmium. Many lamps exhibit a characteristic of toxicity for heavy metals when disposed. Ohio EPA recommends that you manage your spent fluorescent bulbs once they are generated as universal waste.

During Ohio EPA's complaint investigation, no evidence was found proving that latex, ink and corn starch has been buried outside behind the building. Therefore, the complaint is considered closed.

I found the following violation of Ohio's hazardous waste laws. In order to correct this violation you must do the following and send me the required information within 30 days of your receipt of this letter:

1. Used Oil Storage Requirements, OAC Rule 3745-279-22 (C) (1)

Containers used to store used oil shall be labeled or marked clearly with the words "Used Oil".

PPRU failed to mark their two 55 gallon drums with the words "Used Oil".

In order to abate this violation, PPRU must submit photographic documentation showing that the drums of used oil have been labeled with the words "Used Oil".

Ohio EPA will issue an EPA ID number to track our inspection activity at PPRU. PPRU can not use this number for manifesting hazardous waste shipments.

If PPRU wants to use an EPA ID number for manifesting and other hazardous waste, used oil or universal waste activities, PPRU must complete and submit a Notification of Regulated Waste Activity form (EPA Form 9029 (Rev. 11/2002)) to Ohio EPA.

If you find ways to recycle, reduce, or altogether eliminate the amount of waste your company generates you may be able to reduce treatment and disposal costs. Furthermore, you may possibly reduce your regulatory requirements.
