Dear Mr. Lee:

On July 27, 2007, I conducted an inspection of Cullison Scrap Metal in Athens, Ohio to determine the business' compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code and Chapter 3745 of the Ohio Administrative Code. Ohio EPA sent a Notice of Violation letter, dated August 9, 2007, specifying the violations observed during the inspection. Cullison Scrap Metal failed to respond to the Notice of Violation. On September 19, 2007, I returned to Cullison Scrap Metal's to determine your progress in returning to compliance with the previously cited violations.


During my September 19, 2007 visit, you provided the following documentation: a photograph of your labeled used oil container (before it was taken off-site for recycling); and receipts showing disposal of 60 scrap tires, 1 drum of oil/water mixture, and 1,840 pounds of soil contaminated with used oil. During my visit I also observed that your battery storage conditions had been improved. Battery storage had been consolidated to one area on the property. Batteries were stacked on tarped skids. I also observed that the area of ground, which I saw stained with used oil during my July 27, 2007 inspection, had been cleaned up.

My observations during the follow-up visit and my review of the documentation you provided reveals that Cullison Scrap Metal has adequately demonstrated abatement of all violations discovered during the July 27, 2007 inspection.


