**Subject: Notice of Violation - Failure to Sample Drinking Water as Required for Lead and Copper**

Your public water system is in violation of Rule 3745-81-80 through 3745-81-89 of the Ohio Administrative Code for failure to comply with the lead and copper monitoring requirements:

<b>Monitoring Period:</b>	<b>June 1 - September 30, 2009</b>
<b>Required Sampling:</b>	<b>10 samples for each lead and copper</b>


<b>Actions required as a result of the above violation</b>	
Step 1	Collect and analyze the required number of lead and copper tap samples during June 1 - September 30, 2010. Based upon the reported population, you are required to collect a minimum of 10 lead and copper samples. Ohio EPA recommends submitting the Consumer Notice Verification Form and Example Notice with Forms EPA 5105, EPA 5106 and EPA 5107 along with sample results by October 10, 2010 by October 10, 2010.
Step 2	<p>Within 30 days issue public notice of the violation in accordance with rule 3745-81-32 of the Ohio Administrative Code by the following methods:</p> <ol style="list-style-type: none"> <li>1. mail or other direct delivery to each customer receiving a bill and to other service connections; and</li> <li>2. if necessary, the system must also use any other method reasonably calculated to reach all persons.</li> </ol> <p>Note: Systems opting to include the required public notice in the next water bill have up to 90 days.</p> <p>The language in italic on the attached public notice is mandatory and must be included as written.</p>
