**Subject: Failure to Sample Drinking Water for Total Coliform as Required**

Turn Point Apostolic Church PWS is in violation of Ohio Administrative Code (OAC), Rule 3745-81-21 for failure to comply with the total coliform monitoring.

**Monitoring Period:** Fourth Quarter of 2007  
**Required Coliform Monitoring:** 1 per Quarter  
**Sample Results Submitted:** NONE

To ensure the safety of drinking water provided by your system, monitoring for total coliforms is essential.

**ACTION REQUIRED:**

The language in italics on the enclosed public notice is mandatory and must be included, as written. Do not make changes to the public notice without consulting with the Ohio EPA beforehand.

**Complete the enclosed Verification Form within ten (10) days of issuing the Public Notice** and mail it to Ohio EPA - Central District Office. Include a copy of each notice distributed, published or posted.

If total coliform samples were collected as required, submit the results as soon as possible. The monitoring violation would be rescinded and a reporting violation given for late submittal of the results.
