Dear Ms. Green:

On August 17, 2011, I conducted a compliance evaluation inspection of St. Marys Chrysler, Dodge, Jeep, Inc. (St. Marys CDJ) located at 500 McKinley Road in St. Marys, Ohio. I inspected St. Marys CDJ to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). Pollution prevention options were also discussed during this inspection. This letter will explain the violation I found and your compliance with respect to it.

During my visit I spoke with you, Mr. John Dukes, and Mr. Gordon Kill, observed your operations and reviewed applicable paperwork. St. Marys CDJ is a full service dealership. Used oil is generated and stored in three 200-gallon storage tanks located in the shop area. The used oil is picked up in the summer by Safety Kleen and is burned for energy recovery. During the winter, St. Marys CDJ burns the used oil in an on-site furnace. Used oil filters are hot drained and picked up by Safety Kleen to be recycled. St. Marys CDJ does not do any body shop work or painting. Spent fluorescent lamps are managed as universal waste. At the time of my inspection, St. Marys CDJ was operating as a non-generator of hazardous waste.

I found the following violation of Ohio's used oil rules.

1. OAC Rule 3745-279-22(C)(1): Labeling:

Containers, aboveground tanks, and fill pipes used for underground storage tanks shall be labeled or marked clearly with the words "used oil."

St. Marys CDJ had ten portable carboys and three 200-gallon storage tanks that were not properly labeled.

At the time of my inspection, St. Marys CDJ properly labeled the ten carboys and three storage tanks with the words "used oil". A copy of the fact sheet, The Regulation of Used Oil: An Overview for Ohio Businesses Who Generate Used Oil, was given to you at the time of my inspection. Please review this information and contact me if you have any questions.

Therefore, this violation is considered abated.


