Dear Mr. Everhart:

On August 17, 2011, Ohio EPA received a complaint alleging that used oil was being improperly disposed into floor drains and onto the soil at your facility and that scrap tires are disposed on-site. On August 24, 2011, Donna Goodman and I performed a complaint investigation of your facility to determine the validity of the complaint.

Based on the observations made during the investigation, we found no evidence of used oil disposal. We did see a few used or scrap tires at the property, as we discussed, these tires should be disposed properly or (if usable) stored in a manner preventing the accumulation of precipitation. This will help prevent mosquito breeding habitat and serious mosquito-borne diseases such as West Nile virus and encephalitis. Please let me know how you intend to manage these tires.

During the investigation, we noticed several drums and a couple of tanks of used oil were not labeled properly, therefore, you were in violation of the following hazardous waste rule:

- (1) Used oil storage requirements for generators, OAC rule 3745-279-22(C):  
Paragraph (C): Containers and aboveground tanks used to store used oil at generator facilities shall be marked clearly with the words "Used Oil."

During the inspection, you properly labeled the drums and tanks, therefore, you have returned to compliance with this regulation.

You have abated all the violations we observed, I have included the checklists I used to evaluate your operations and a factsheet for managing used oil.
