NOTICE OF VIOLATION - ACTION REQUIRED

Subject: Failure to Sample Drinking Water for Total Coliform as Required

New Life Tabernacle Ministries PWS is in violation of Ohio Administrative Code (OAC), Rule 3745-81-21 for failure to comply with the total coliform monitoring.

Monitoring Period:	Second Quarter of 2010
Required Coliform Monitoring:	1 routine per Quarter
Sample Results Submitted:	Zero

To ensure the safety of drinking water provided by your system monitoring for total coliform is essential.

ACTION REQUIRED:

- 1. Notify the people served by this water system** using one or more of the methods and the timing as required by OAC, Rule 3745-81-32 to reach all persons served.

Timing: As soon as practical, but no later than 30 days after learning of the violation:

- Posting in conspicuous location, such as bulletin boards, restrooms, drinking fountains, vending areas;
- Mail or other direct delivery to each customer;
- Newsletters or newspaper;
- E-mail to employees or students;
- Send to parents or guardians of children at schools or day care facilities;
- Posted notices must remain in place as long as the violation or situation exists, but in no case less than seven days (even if the violation is resolved). The language in *italics* on the enclosed public notice is mandatory and must be included, as written. Do not make changes to the public notice without consulting with the Ohio EPA beforehand.

- 2. Complete the enclosed Verification Form within 10 days of issuing the Public Notice** and mail it to Ohio EPA - CDO. Include a copy of each notice distributed, published or posted.


