**NOTICE OF VIOLATION - ACTION REQUIRED**

**Subject: Failure to Monitor Drinking Water**

Jerusalem Evangelical Lutheran Church Pw is in violation of Ohio Administrative Code Rule 3745-81-24 for failing to monitor your drinking water during the July 1, 2009 to September 30, 2009 monitoring period and/or report results for the following contaminants: VOLATILE ORGANIC CHEMICALS (VOCs)

**In order to return to compliance,** Jerusalem Evangelical Lutheran Church Pw must take the following actions:

1. Immediately collect a sample of your drinking water from the entry point (first tap after treatment).
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.

Your prompt attention to this matter is greatly appreciated. Continued noncompliance may lead to enforcement actions. If you have any questions or if the required sample was tested, please call me at (614) 644-2752.

# DRINKING WATER NOTICE

## Monitoring requirements not met for Jerusalem Evangelical Lutheran Church Pw

*We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During the July 1, 2009 to September 30, 2009 time period we did not monitor for the following contaminants and therefore cannot be sure of the quality of our drinking water during that time: VOLATILE ORGANIC CHEMICALS (VOCs).*

### ***What Should I Do?***

This notice is to inform you that Jerusalem Evangelical Lutheran Church Pw did not monitor and report results for the presence of the contaminants listed above in the public drinking water system during the July 1, 2009 to September 30, 2009 time period, as required by the Ohio Environmental Protection Agency. You do not need to take any actions in response to this notice.

### ***What Is Being Done?***

Upon being notified of this violation, the water supply was required to have the drinking water analyzed for the above mentioned parameters. The water supplier will take steps to ensure that adequate monitoring will be performed in the future.
