The Ohio Environmental Protection Agency (Ohio EPA) has reviewed the following document:

Ground Water Quality Assessment Plan - Revision 7

The document, dated December 28, 2011, was prepared by Eagon & Associates, Inc. on behalf of Central Waste Landfill, LLC, and was received by Ohio EPA on December 29, 2011. The Central Waste Landfill, LLC ground water monitoring program is regulated by the Solid and Infectious Waste Regulations (**OAC 3745-27-10**), effective August 15, 2003.

Revision 7 addresses changes to Section 6.0 - Assessment Data Evaluation Procedures of the GWQAP to address Ohio EPA's November 30, 2011 Notice of Violation (NOV) of OAC Rule 3745-27-10(E)(4)(e) requiring that the GWQAP include a description of data evaluation procedures and to update Section 7.0 - Assessment Plan Schedule, and Figure 10. The revisions were submitted, in part, to address Ohio EPA's November 30, 2011 NOV and comments. According to the cover letter with the submitted revision, the comments will be addressed in a separate letter. Revision 7 includes the following:

- Pages 2-4 of Section 2.3 Site Hydrogeology


COMMENTS
