NOTICE OF VIOLATION - ACTION REQUIRED

Subject: Failure to Monitor Drinking Water

Lazy River Campground is in violation of Ohio Administrative Code Rule 3745-81-23 for failing to monitor your drinking water during the January 1, 2009 to December 31, 2009 monitoring period and/or report results for the following contaminants: NITRATE (AS N)

In order to return to compliance, Lazy River Campground must take the following actions:

1. Immediately collect a sample of your drinking water from the entry point (first tap after treatment).
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.

Your prompt attention to this matter is greatly appreciated. Continued noncompliance may lead to enforcement actions. If you have any questions or if the required sample was tested, please call me at (614) 644-2752.

DRINKING WATER NOTICE

Monitoring requirements not met for Lazy River Campground

*We are required to monitor your drinking water for specific contaminants on a regular basis. What Is Being Done?

Upon being notified of this violation, the water supply was required to have the drinking water analyzed for the above mentioned parameters. The water supplier will take steps to ensure that adequate monitoring will be performed in the future.
