**Subject: Failure to Monitor Drinking Water**

Mccartyville Well Association PWS is in violation of Ohio Administrative Code Rule (OAC) 3745-81-23 for failing to monitor your drinking water during the Third Quarter of 2010 monitoring period and/or report results for the following contaminants: ARSENIC.

In order to return to compliance, Mccartyville Well Association PWS must take the following actions:

1. Immediately collect a sample of your drinking water from the entry point (first tap after treatment).
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.

Your prompt attention to this matter is greatly appreciated. Continued noncompliance may lead to enforcement actions. If you have any questions, or if the required sample analysis was performed, please call me at (614) 644-2752.

# DRINKING WATER NOTICE

## Monitoring requirements not met for Mccartyville Well Association PWS

*We are required to monitor your drinking water for specific contaminants on a regular basis. ### What Should I Do?
