Subject: Failure to Monitor Drinking Water

Hillview Mobile Court PWS is in violation of Ohio Administrative Code Rule (OAC) 3745-81-24 for failing to monitor your drinking water during the Fourth Quarter of 2007 monitoring period and/or report results for the following contaminants: TOTAL TRIHALOMETHANES AND HALOACETIC ACIDS, FIVE.

In order to return to compliance, Hillview Mobile Court PWS must take the following actions:

1. Immediately collect a sample of your drinking water from the maximum residence time location (point in the system where the age of the water is the oldest).
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.

Your prompt attention to this matter is greatly appreciated. Continued noncompliance may lead to enforcement actions. If you have any questions or if the required sample was tested, please call me at (614) 644-2752.

DRINKING WATER NOTICE

Monitoring requirements not met for Hillview Mobile Court PWS

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During the Fourth Quarter of 2007 time period we did not monitor for the following contaminants and therefore cannot be sure of the quality of our drinking water during that time: TOTAL TRIHALOMETHANES AND HALOACETIC ACIDS, FIVE.
