Dear Ms. Brown,

The NPDES permit for the above facility includes a Schedule of Compliance. The Schedule of Compliance requires the submittal of a Permit to Install (PTI) application and detailed plans for achieving final compliance for outfall by **July 1, 2007**. This office to date has not received a PTI application for this facility.

Also, Ohio EPA has reviewed your Monthly Operating Reports (MORs) covering the months of July 2006 through June 2007 for the referenced facility. Our review indicates violations of the conditions of your NPDES Permit (NPDES Permit # OH0137529; OEPA Permit # 1PX00058*AD). The specific instances of noncompliance and/or deficiencies were as follows:
