Dear Ms. Reece:

This office has received the non-compliance notifications for the above referenced facility. Our review indicates violations of the conditions of your NPDES permit. The specific instances of non-compliance and/or deficiencies were as follows:

EFFLUENT LIMIT VIOLATIONS

In addition, on February 27, 2008, notification was received of a release through outfall 002 at the facility. At approximately 4:00 pm, a stream of white water was noted coming out of outfall 002. Approximately 50 gallons of latex had mixed with the water from the silo complex. This resulted in the latex mixing with approximately 334,400 gallons of water in the 002 pond that discharged to the Ohio River. Approximately 83,600 gallons was captured and routed back for treatment. At 2:00 am on February 28, 2008, the 002 pond was returned to normal service.

Please be advised that failure to comply with the effluent limitations, or to satisfy monitoring or reporting requirements of your NPDES permit may be cause for enforcement action pursuant to the Ohio Revised Code Chapter 6111.




