NOTICE OF VIOLATION

Dear Mr. Montgomery:

You are hereby notified that the Ohio Environmental Protection Agency (Ohio EPA) finds you to be in violation of Ohio's open burning regulations. On July 25, 2008 and August 11, 2008 open burning complaints were filed with the agency. Mr. Craig Osborne and I investigated the first complaint on July 28, 2008. I investigated the second complaint on August 13, 2008. On both occasions, it was determined that open burning of solid waste had occurred at or near property occupied by Montgomery's Auto Salvage, 139 Broadway St. North, Midland, Ohio.

The violations you have committed include, but are not limited to the following:

- The open burning of solid wastes, including solid wastes made from petroleum products including tires.

The above identified activities are in violation of Ohio Administrative Code (OAC) rule 3745-19-03, Open burning in restricted areas, and Ohio Revised Code (ORC) Section 3704.03. In addition, the open burning of solid waste is in violation of OAC rule 3745-27-05(B) and ORC Section 3734.03.

You must cease all illegal open burning.

Based on Clinton South Fire Department run reports, this is not the first time the fire department has been called to extinguish this type of fire at your business. Please be aware that this investigation will be sent to our Central Office for further review and possible enforcement. The Ohio EPA reserves the right, pursuant to Chapters 3704, 3714, 3734, 3745, and 3750 of the Ohio Revised Code and any other applicable state
