Self-Monitoring Report NOV – May 2009 through August 2009

Dear Ms. Lytle:

We have received your self-monitoring reports covering the months of May 2009 through August 2009 for the above-referenced facility. Our review indicates violations of the conditions of your NPDES permit. The specific instances of noncompliance and deficiencies were as follows:

**Part II, Item A (Classification of Wastewater Treatment Works** – On December 31, 2008, David Leist was no longer a certified operator in the state of Ohio. Part II, Item A requires Husted to have a Class I operator to oversee the technical operations of the wastewater treatment plant. Husted is in violation of Part I, A for failure to have a Class I certified operator,

**Part II, Item B (Operator of Record)** - Within three days of a change in an operator of record, Husted is required to notify Ohio EPA of this change on the Operator of Record Notification Form (EPA 5121). Husted failed to notify Ohio EPA of this change in violation of Part II, Item B. This form may be obtained at the following link: <http://www.epa.ohio.gov/LinkClick.aspx?fileticket=7fKxZGllvBY%3d&tabid=3650>. Immediately submit this form to Ohio EPA. Please provide a copy of this form to this office.

**Chlorine Reporting.** During the period from May 2009 through August 2009, Husted is reporting chlorine as "0." This is improper reporting. If Husted is detecting chlorine below the detection limit, then place "AA" in the column and state what the detection limit is in the comment section.




