



We have reviewed your report addressing the reasons for the above violations and the actions being taken to prevent further occurrences. Ohio EPA acknowledges that the City is planning to connect the satellite WWTP to the main WWTP in approximately 30 months; however, we need additional information on the operational and/or maintenance actions that have been taken or will be taken to bring the WWTP into compliance with final effluent limits. We consider this WWTP to be in significant noncompliance.
