Dear Mr. Agresta:

Thank you for accompanying me during Ohio EPA's February 3, 2012 inspection of Terrell Manufacturing (Terrell) in Strongsville, Ohio. I inspected Terrell to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). My inspection included a review of company operations and written documentation. In addition to the inspection for compliance with Ohio's hazardous waste rules, the facility was inspected for compliance with Ohio's used oil rules.

Terrell is a manufacturer of custom hydraulic manifolds used by plastic injection mold machines. Processes include the machining of steel, aluminum, cast iron, and stainless steel and part assembly. The facility currently is not generating hazardous waste. Waste hydraulic oil and water based cutting fluid is generated by Terrell along with universal waste lamps.

The following violations of Ohio's used oil rules were found during this inspection:

- 1. Used Oil Generator Standards, OAC 3745-279-22(B):** Containers used to store used oil must be in good condition. At the time of my inspection, three drums containing waste coolant were in poor condition, having collapsed from an attempt to vacuum out their content by your used oil recycler, Everclear, Inc. As waste coolant remained in the drums, this is a violation of OAC 3745-279-22(B). To return to compliance with this rule, transfer all waste coolant/oil from the damaged drums to undamaged drums and submit a photograph of the replacement drums.
- 2. Used Oil Generator Standards, OAC 3745-279-22(C):** Containers, above ground tanks, and fill pipes used for underground tanks used to accumulate used oil must be clearly labeled or marked "Used Oil". At the time of my inspection, 55-gallon drums containing used oil and used cutting fluid coolant were observed


but were not all labeled. This is a violation of OAC 3745-279-22(C). "Used Oil" labels were applied to these containers during my inspection returning Terrell to compliance with this rule. No further action by Terrell is required with regards to this violation.

Terrell needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, Terrell is requested to provide documentation to this office including the steps taken to abate the violations cited above. Documentation of steps taken to return to compliance includes written correspondence, updated policies, and photographs, as appropriate, and may be submitted via the postal service or electronically to tom.roth@epa.ohio.gov.

Please be advised that violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734 of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. It is imperative that you return to compliance. If circumstances delay the abatement of violations, Terrell is requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.
