

RE: V. E. Beard Oil Company, Inc. NPDES Permit Compliance / Schedule of Compliance Notice of Violation.


Dear Mr. Beard:

Ohio EPA has reviewed the Electronic Discharge Monitoring Reports (EDMR's) file for Beard Oil for the period of January 1, 2009 through December 31, 2009. During this time period there were no submittals for the facility. This is in violation of your National Pollutant Discharge Elimination System (NPDES) permit (1IN00282 / OH0133990).

In addition to the final effluent reporting violations V. E. Beard is in non-compliance with their NPDES permit compliance schedule Part 1, C "Schedule of Compliance". Specifically, V. E. Beard has failed to comply with schedule items (1), Permit to Install submittal for an oil water separator, item (2) initiate construction, item (3) complete construction, and item (4) provide written verification concerning the completion of items 2 and 3.

These violations have placed the V. E. Beard Oil Company in significant noncompliance with the NPDES permit. A written response detailing the actions being taken or proposed to eliminate and prevent further violations must be submitted to this office as soon as possible, but no later than April 12, 2010.
