Ohio EPA has reviewed the monitoring reports for the Paris Court Mobile Home Park wastewater treatment plant from the period of September 2010 through February 2011. This review revealed violations of the conditions of your NPDES permit. Instances of non-compliance are listed below

In addition, provide documentation of the site approval for the fields being used to apply sludge from the wastewater facility. Provide the requested information by April 19, 2011. Please be advised that failure to comply with the effluent limitations or to satisfy the reporting requirements of your NPDES permit may be cause for enforcement action.
