**Subject: Failure to Monitor Drinking Water**

Joy Baptist Church is in violation of Ohio Administrative Code Rule (OAC) 3745-81-23 for failing to monitor your drinking water during the January 1 to December 31, 2011 monitoring period and/or report results for the following contaminants: NITRATE. A nitrate report was received for a sample collected on January 9, 2012.

**In order to return to compliance**, Joy Baptist Church must take the following actions:

1. Notify your customers using the enclosed instructions and public notice.
2. Complete and return the enclosed verification form to this office.

# DRINKING WATER NOTICE

## Monitoring requirements not met for Joy Baptist Church

*We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. ### What Should I Do?
