Dear Mr. Baker:

On February 9, 2012, Kris Coder and I, representing the Ohio EPA's Division of Materials and Waste Management, conducted a hazardous waste compliance inspection of your facility located at 1331 Emmitt Road, Akron, Ohio. We inspected the facility to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC).

During the inspection, it was determined that the facility is a conditionally-exempt small quantity generator of hazardous waste (less than 100 kilograms generated per month). The following violation of Ohio hazardous waste laws was found during the inspection:

**OAC Rule 3745-279-22(C), Used Oil Generator Standards:** All containers and aboveground tanks used to store used oil must be labeled or marked clearly with the words "Used Oil."

A drum containing used oil located in the maintenance area was not properly labeled with the words "Used Oil".

During the inspection, a "Used Oil" label was given to maintenance personnel and applied to the drum. The violation was abated so no further action is required.
